INFORMATION ABOUT SERVICES

Service Description

The service is an enhanced business internet service over the nbn™ available to business customers. The service is a broadband service which uses the nbn™ network utilising dedicated backhaul, and a dedicated NTU (Network Terminations Unit) and provides access to the Internet and related services, such as VoIP and email and comes with a private static IP address.

The service has the following options:

- ECN supplied and managed router
- Enhanced Service Assurance (Restoration)
- Speed Boost upgrade to 100/40Mbps

Bundling requirements

ECN does not require that you bundle this service with any other service.

Availability

ECN Business Internet is available subject to infrastructure availability at customer's premises. Certain nbn™ service technology types (HFC, Fixed Wireless) are not compatible with nbn™ Enhanced Broadband. FTTN FTTB and FTTC) require a standard PSTN copper line to be connected at the premises. Speeds

Plans delivered on the nbn™ network are provided as per the bands in the Information about Pricing table below. The actual speeds for the service may be slower and vary due to many factors including type/source of content being downloaded, hardware and software configuration, the number of users and performance of interconnecting infrastructure not operated by ECN. This Service provides a maximum access line speed of 50Mbps (download) and 20Mbps (upload).

Additional upgrade provides a maximum access line speed of 100Mbps (download) and 40Mbps (upload).

Equipment Required

You need an nbn™ Enhanced Broadband compatible modem to connect your devices to ECN nbn™ Enhanced Broadband Internet services

If we find that you will require a technician visit to perform an installation, we will provide a quote for services separately to the registration process.

Minimum Term

Business Internet service are available on 36-month minimum contract terms. See Minimum Total Cost applicable to each plan in the Information about Pricing section.

Cancellation/Early Termination Charges

For Enhanced nbn™, terminating a contract within the first 36 months will require that the balance of the remaining full 36 months of the contract is paid to ECN. Terminating a contract outside of the first 36 months for ECN Enhanced nbn™ will not attract any termination charges. ECN requires 30 Days written notice to terminate an nbn Enhanced Broadband internet service. You will be billed for use in the month in which you notify in writing your wish to terminate your contract.

Changes to Contract

You cannot upgrade or downgrade your nbn™ Enhanced Broadband internet service once ECN have accepted your order and created your Order Acceptance Notice. If relocating an ECN nbn™ Enhanced Broadband internet a \$199.00 (Inc. GST) fee will apply for reconnection.

Billing

This is a post-paid service. You will be billed monthly, with invoices sent to your registered email address. Depending on your plan, an activation fee may be payable. ECN offers Business Internet services via the National Broadband Network (nbn™) as either a Standard service or an Enhanced Broadband internet service. Monthly service rental charges are billed in advance.
